Technical Services Department, 11545 Pacific Avenue, Fontana, CA 92337; (3) the stability of the product installed or its suitability for installation; (4) condition of the sub-floor, including but not limited to excessive moisture, alkalinity or hydrostatic pressure.

### NOTICE OF CLAIMS
